### 2. Land Acknowledgement - Reconnaissance des Terres (3 mins)

We pledge to engage in dialogue, to listen with open hearts, and to forge relationships built on mutual respect and shared purpose. We invite those who are not on this land to reflect upon the territories they occupy, wherever they may be. Resources such as native-land.ca can offer guidance in identifying the Indigenous lands on which we live, work, and gather, encouraging an ongoing process of learning and recognition.

As we walk forward, may we do so with mindfulness of the past, attentiveness to the present, and unwavering commitment to a future where the rights and treaties of Indigenous peoples are upheld and honored. ### Aya - VP Merch

- 2 designs made up for voting with the execs to choose which one we prefer
- need to make sure which programs fall into IEEE so which ones we make merch of
- we need to decide the discount for IEEE memberships and IEEE execs
- Right now consensus is quarter zips for exec merch but up for discussion
- We need to decide if we are buying bulk basics (shirts, crewnecks etc.) and printing ourselves either at a place specialized or for free at CEED (if we decide to do this we'd need all hands on deck depending on the amount we need to make, or we go with a supplier (would be more expensive and quality not as good

Aya: 2 designs and I want to hear everyone's opinions. I want to hear everyone's ideas. I was thinking of multiple items per program, so we can choose those designs. I want to set up a vote for these two.

Akhil: I'm not going to lie those designs are good

Aya: I also wanted to ask what programs fall in IEEE which are included in the merch or all stem

Jad: we have SEG, CEG, and electrical MDD

Eric: for the noise computer design I don't think the font is electrical at glance so I would tweak that

Xavier: There's going to be different designs for every faculty. You're voting for the general design and style

Aya: this will change for every program and there will be discussions on what items to choose

Jad: which items to choose as in what colors?

Aya: yes. I wanted to also talk about discounts in IEEE memberships. We should include a discount to the merch with the membership, so we should talk about what that discount is. We're going for quarter zips for exec merch. I was talking to manaal too so we either do bulk purchases and then print them at a printing supplier which is less expensive.

Manaal: circle back to that, I am in a dilemma because I want to test out that printing which might not be a viable option. It might be better to order for affordability. Personally I want to save those resources and invest it into something else.

Aya: I still think getting t-shirt bulks is less expensive.

Jad:for the IEEE memberships the discount should be 20%

Aya: that's a lot

Jad: We need to market it a lot. For the lanyards so we might do a little give-a-way in discord.

Manaal: I hope everyone here got their membership, if not, get it. The time between this meeting and the next should be a good time to find a supplier, find quotes, and get it all together. Exec discount should be around 40%, important to take care of execs.

Joey: I can set up a discord give a way system

#### **Going through**

Jad: start with VP Equity battle royal

Farah: I helped out with battle royal last year and it's a similar amount we budgeted. You and I can set up a meeting with carleton(Xavier)

Xavier: I looked at the budget so sounds good.

Jad: so you can see our bank account which isn't that much. There are some events that have revenue. If you do have any revenue bring it up now and explain the event and what the money is used for

Xavier: part of my mandate I need to do 1 event per sem I don't know what to do for fall yet. Battle royale costs nothing but I put 1000 but we can put a lot less.

Manaal: Rather than spending resources you can add a philanthropic aspect to another event which satisfies your mandate.

Xavier: you can strike the battle royal event from the sheet

#### Discussion:

Jad: does anyone have a discussion for battle royal?

Farah: good if we apply for winter funding.

Manaal: For this budget I want to say it is final but not written in stone. 15000 is a good amount. It should not be costing really a lot.

Farah: last year prizes were 500 dollars so not a lot

Jad: Next topic office snacks

Fayza: I can talk about everything of mine in one go. Paint can be scraped. So I just want printer refills and office snacks. I want to talk about office chairs, so many broken chairs on the side. I did want to replace some of the chairs or just chair covers. If we are striking things like the paint, when the mcnaughton grant comes in, if there is any equipment or anything you want to say, so I can put it in when applying to the grant.

Jad: I remove the paint?

Fayza: yes

Jad: for the office chairs. You can do equipment expansion or when do you apply for the grant

Fayza: due in november but I want to apply by end of month.

Jad: if grant doesn't come in I dont want to spend too much.

Manaal: office chairs should not cost anything because we have approved chairs at SITE no one picked up. For mcnaughton grant gets approved, we put it on the sheet. If not approved we just motion to strike it from the sheet or move it somewhere else

Jad: I am going to strike office chairs and replace them with something. Equipment expansion last year was 4k, office supplies is 250.

Eric: Last year office supplies was a spending year.

Fayza: we have a lot of stuff but I am sure a lot of it is not working.

Jad: if the expense is not here you can bring it in any exec meeting or discord. Preferably everything should be on here.

Fayza: let's do it later I can't estimate. Just things like snacks and printer refills should stay there

Jad: We are keeping office snacks and printer refills and office supplies. Office snacks are allowed for exec members or IEEE member. Don't let anyone take too many snacks

Manaal: I bought a fan for the table, office property whenever I bring it in, don't let anyone take it

Aya: So for my merch amount, so what I was thinking we do the pre order system we can market and put the merch on the website, and with the money we can use it to order so I don't know how much we have to use from bank account.

Manaal: however much as an org we spend, we should put that on the budget. It's just that if we make money off of it, we can still put it on the budget. Personally I don't think we should spend that much on merch

Jad: move onto SPAC

Farah: I request 2500 because my deadline is coming up. We do have sponsors coming in quickly but this is based on previous year budget. Any questions about SPAC specifically would go towards transportation so our students could make it to the conference in Kanata. I could pull out the SPAC budget as well. We would technically become a gold patron

Jad: so the 2500 would there be revenue

Farah: probably no

Farah: We can apply to EF after. Date for SPAC is nov 1st. Deadline is october 15th which is worst case

Manaal: let's say we give 2500 now, it would take 2 and a half months to get that back in our account. We have to figure out a way to find out when that is coming in and if we are all ok with that money going out of our account.

Farah: First time IEEE is collabing with SPAC, and present at the same weekend we are doing SPAC, and our students will get an opportunity to engage with IEEE ontop of sponsors currently.

Manaal: I will get info on our bank account and incoming money and we'll bring it to a virtual vote before the deadline. After evaluating our expenses further I can't make a decision now. Our options right now are(later) we approve this, we approve another amount or we don't approve it at all. I propose we have a virtual ballot next wednesday

Jad: we don't have a treasurer so this is not good. It is a lot of pure net loss, this is not the only event we will do.

Farah: would it be better to put a minimum amount

Eric: earlier on you mentioned 3 options with SPAC, I advocate for 4th option instead of suspending the vote of this line item, but table the overall amount till later

Manaal: Give me till wednesday, so strike the SPAC thing for now and we can amend it later

Farah:We can strike it but I want to emphasize the deadline, so would wednesday be a good deadline for sure

Jad: we can set it in discord. I stress the whole committee for any expense at all. Say what your opinions are. Winter industry event now.

Farah: In the winter I was thinking of hosting a panel for a company or two only expenses are bring snacks. 300 dollars max

Manaal: I know WIE does annual industry event so maybe a colab

Somona: Early to mid october

Farah: I was thinking of more winter, can't do September or October because of other stuff. But if you do need recruiters I can reach out.

Somona: Regarding the winter we can do the WIE panel together

Manaal: January is coming back semester so we might be able to do it then, but feb is hackathon and we should consider when to book around certain dates. Should we do our own independent event or colab with another org

Farah: I know for MESS, we can maybe colab with mess.

Manaal: Let's keep that expense in

Jad: next is cookies and cram.

Joey: Cookies and cram is around 400 for 14x4 events for the whole term based on last year. Quiz me is around 650

Eric: like around 7 dollars per individual cookies and cram event

Jad: based off last year. Cookies and cram is one of our main events. If there is not enough we can do a discord motion for more money. So now UO ENg Life events

Eric: I was originally budgeting less money for this so 650 is good, we got no student life in engineering, so I want to involve more student clubs.I was thinking for popcorn chips and sodas, so cheaper options.

Jad: I agree, 650 is not needed to be used. So if Pizza is not needed then we can switch it out which is better

Manaal: I been talking to people around campus, everyone is struggling with money. So get as many people involved as you can. Second note is like Jad mentions, if you need more or need less just bring it out. Get a rough idea of what you want to do. Money allocated might change, just get it done ASAP.

Eric: I will talk after the meeting for that

Jad: We will move onto Wine and cheese for WIE

Madison: same amount as last year, we did spend a little over last year but made more. We might switch things with venue and catering, and different options for photography and photo booth.

Manaal: for photo booth thing, I was looking into it, it's not as impossible and you can buy your own equipment for WIE or IEEE and keep it in the office and set up our own photo booth for every event, it's not expensive

Akhil: Regarding events and photography I can help I have equipment. I can bring studio light and extra gear. So contact me

Manaal: Whenever you guys have it, we should set a day IEEE for budget for this event to see if everything is adding up. Us as IEEE we might have to request budget from you guys(WIE). Whenever you have your outlying budget send it over.

Madison: should be finalized by end of september

Jad: now IEEE day

Quinn: I allocated slightly strong for 500. I would like to have it there when I start planning it.

Jad: this year's IEEE day is big

Manaal: IEEE day is very important to us, but 500 is very steep which is almost as much as Eric's events. Last year we spent less than 90. We can even do 250 for a good experience

Quinn: I will drop it down to 250.

Farah: When is IEEE day

Manaal: October 1st

Jad: now to 101ers event

Akhil: this is doomsday price(1000) this is worst case. We might not even have expenses.

Aya: this is helping students study and stuff how is that different from cookies and cram

Akhil: it is very different from my previous idea. You could put it in 100 and should be good. Just for food and stuff,

Joey: Other than us IEEExnotion what do students gain.

Akhil: it is more of an event for first years to address their questions on how to study and exam prep and planning. This event has that goal of fixing those issues. I know a lot of students struggle with that, because 1st year is the worst year. People can make friends in that event and form study groups.

Xavier: if it is anything related to school VP Academic could be included

Eric: in interest of targeting people with study we should include Equity

Jad: 1000 dollars is crazy. In the mind of a 1st year, it's more partying and fun than a presentation

Manaal: main concern is that it looks like a supplication event. I know a lot of sub associations have similar events. I want to propose cancel the name 101ers event, and rename IEEE X Notions event and explore that collaboration.

Aya: same thing, put more emphasis on Notion and what you can do with that

Joey: when is this event held

Akhil: last week of september or early october

Jad: this is what the event calendar is for

Farah: I want to mention we should invite profs to this event.

Akhil: helpful I will add that to the event

Manaal: Don't do anything from 22nd of september to october 8th. This is where events calendar is highly crucial for us.

Jad: Now Movie night

Akhil: again max 200 but probably cheaper. Mainly for snacks, we could do cheaper food options, maybe 90 dollars.

Joey: let's dock it to 100
Aya: would you guys be seeling tickets or is it free
Akhil: should be free
Fayza: Are we going to try to cater to the french or is it just english
Akhil: we can do both
Eric: I opened Vp internal email what is it used for
Jad: it is useless but we need it for a workspace and drive. It is also used for merch and everything like that. The email space is not used but workspace is important and we can bring this to another meeting
Manaal: I want to add another budget line for google workspace email for 1029.56. More we save on licenses the better. If you are not using it let us know.
